Keynote: Rita Indiana Hernández (Santo Domingo/ Puerto Rico)

Skaters and drag queens, DIY Dominican Cultural Ecology:

In Santo Domingo of the gos, subcultures flourished and with them, practices and discourses that enabled a new ethical platform for artistic production. The city, its precariousness, self-management and spectacle defined this dynamic cultural period.

Rita Indiana is a Dominican writer, songwriter and singer. She published the novels La estrategia de Chochueca (2000), Papi (2004), Nombres y Animales (2014) and La Mucama de Omicunlé (2015.) The latter was a finalist of the Vargas Llosa Novel Biennial in 2016, which was the first novel in Spanish to receive the Prize of the Association of Writers of the Caribbean. Her literary and musical discourse is nourished by the culture, the marginal and popular Dominican language as well as by diverse Afro-Caribbean magical-religious traditions. In 2009 she reinvented merengue and other folk rhythms in electro fusion with her group "Los misterios". In "Made in Saturn", her most recent novel, she visits the nostalgic relations between Cuba and the Dominican Republic and the ideological devastation in both from the point of view of a protagonist who receives treatment for his addiction to heroin in a clinic/hotel in Havana.

Thursday, May 31st

Panel 1: Culture and Nature: From Cultural Establishments to Cultural Ecologies.

Art and culture will be seen as interdependent with, and transfused by, political and economic realities, ecological processes, and natural cycles in the context of the Caribbean. Presenters will address strategies for functioning optimally in our particular environments (including, at times, rogue states and failing systems); devise ways in which we might rebuild broken methodologies; and consider the potent roles of cultural actors in our complex archipelagic networks. Where in the Caribbean's cultural ecology can we find best practice models that respond to this specific ecosystem in ways that benefit all of the organisms in the blueprint?

Sobremesa: Conscious of the geographical context in which the fourth iteration of Tilting Axis is taking place, the core team is pleased to include a new conversational exchange format in this year's programme, inspired by a Dominican tradition called Sobremesa. Sobremesas are informal, relaxed conversations that typically happen after meals, with coffee, and are characterised by ease and the open sharing that often takes place in kitchens, across the Caribbean.

Each session will be allotted 45 minutes, providing two specially invited guests with an opportunity to engage in conversation, exploring natural overlaps in their practice or philosophies. The wider group of Tilting Axis participants will be invited to bring their coffee and listen in on the Sobremesa.

Pop Up Presentations: Tilting Axis is keen to have a better understanding of critical local, Caribbean, and diasporic projects that we might not be aware of, we have decided to introduce a suite of daily pop-up presentations into the forum. Each session will be allotted 10 minutes, providing Caribbean practitioners or those working within diaspora-based communities opportunities to share their projects and update us on continuing works. This is a way to form and ensure a more inclusive and socially oriented dialogue with such a large gathering.

Ideas Lab: Moderators will spark discussions on topics related to each day's panel theme. Participants will debate in smaller groups and then share their ideas with the larger crowd.

Panel 2: In(stitutional) Context: Acting in the Wake of Change.

In our current cultural ecology, it is easy to misinterpret the function of institutions and their relation to service. The question of clarifying our audience and who we serve remains a critical point of departure for many of us. Within the context of our various locales, we will address how social concerns are pushing institutions into new territories and provoking definitions of what it means to exist in a time when dissident practices, social activism, and revolt are becoming more prevalent across our spaces. As arts and cultures evolve, the nature of the institution as an agent for social transformation is implicit in this newly found ecology. Pioneers and provocateurs in the field will address how their practices have developed in tandem with public consciousness and what it means for the future and sustainability of the institution.
